EXECUTIVE ORDER NO. 2020 - 048 - C

**AN EXECUTIVE ORDER INSTITUTING ADDITIONAL MEASURES
FOR A STRICTER BORDER CONTROL WITHIN THE
TERRITORIAL JURISDICTION OF LAPU-LAPU CITY**

WHEREAS, as of April 17, 2020, there are already 8 confirmed cases in the City of Lapu-Lapu;

WHEREAS, despite the city's efforts to limit the movement and interaction of people, there are still those who blatantly disregard the precautionary measures being implemented;

WHEREAS, there is also a need to strengthen border control measures as it has been observed that they are still a considerable number of persons and vehicles that regularly ply the streets without any valid reason;

NOW, THEREFORE, I, JUNARD "AHONG" Q. CHAN, Mayor of the City of Lapu-Lapu, and by the virtue of the powers vested in me by law, do hereby order and decree the following additional measures to impose a stricter border restriction resulting to the further limitation of movements within Lapu-Lapu City.

SECTION 1. NUMBER CODING SCHEME FOR VEHICLES- To limit the use of vehicles, including motorcycles, effective 20 April 2020, the last digit of the vehicle plate shall be made as a basis for when it is allowed to be used and the following scheme shall be followed:

**MONDAY
WEDNESDAY
FRIDAY**

ODD Numbers: 1, 3, 5, 7, 9

**TUESDAY
THURSDAYS
SATURDAYS**

EVEN Numbers: 2, 4, 6, 8, 0

SUNDAY AM: 12:00 am - 11:59 AM

ODD Numbers: 1, 3, 5, 7, 9

SUNDAY PM: 12:00 nn - 11:59 pm

EVEN Numbers: 2, 4, 6, 8, 0

For vehicles with a temporary plate, for easy reference, the last digit of the conduction sticker/number will be followed.

SECTION 2. EXCEPTIONS TO THE NUMBER CODING SCHEME – The vehicles used by the following shall be exempted in the number coding scheme:

- (a) Doctors, Nurses and other Hospital Workers and Staff provided that they will present a company ID and Certificate of Employment accompanied by their corresponding work schedule;
- (b) Emergency vehicles (i.e. ambulance, fire trucks, rescue vehicles, and the like);
- (c) Government vehicles;
- (d) Government Officials;
- (e) Government Employees, provided that they will present a government ID and a Certification from the LGU that they are a front liner or part of the skeletal workforce of the said LGU;
- (f) Members of the PNP, Military Personnel, and force multipliers;
- (g) Those who will undergo a medical check-up, treatment, procedure provided that they secure a Certificate to Travel issued by the LGU and the said certification must be only for the specific date of travel;
- (h) Delivery Vehicles of essential goods provided that they will also secure a Certificate to Travel or delivery permit from the LGU prior to the delivery;
- (i) Vehicles, whether personal or company-provided, transporting employees of an exempt establishment or those issued with special permit provided that they will also secure a Certificate to Travel from the LGU and transport is only within Lapu-Lapu City;
- (j) Buses deployed by the local government for transportation of its residents;
- (k) Vehicles of market vendors including those who are part of the Market-on-Wheels activity provided they have a Market Pass;
- (l) Other persons or establishments as may be exempted by the Mayor;

SECTION 3. MANDATORY PROVISION FOR LIVING QUARTERS FOR WORKERS- Those business establishments that are exempted by Executive Order No. 2020-48 or those establishments who are given Special Permits to operate are hereby mandated to provide living quarters to all their employees who are non-residents of Lapu-Lapu City. This provision will also apply to promodisers assigned in respective groceries or supermarkets. The goal of this provision is to further limit the movement of the exempt employees from crossing one border to another.

SECTION 4. STRICTER IMPLEMENTATION OF CHECK POINTS IN THE BOUNDARIES OF LAPU-LAPU CITY. - The Philippine National Police (PNP) is hereby mandated to strictly implement the provisions of the Executive Orders issued by the Office of the City Mayor in relation to border control. In this case, the following shall be observed:

- (a) Strict inspection of the vehicles in the check points. The PNP Personnel or their force multipliers will have to ask the reason(s) as to why they will enter the territorial jurisdiction of Lapu-Lapu City. Further, they must inspect all document(s) that will prove that the person is covered under exempt individuals in Executive Order No. 2020-48.
- (b) For delivery vehicles, the driver must submit the vehicle to a thorough inspection including the items for delivery.
- (c) To implement further the principle on strict social distancing, only two passengers are allowed in a private vehicle, with the passenger seated at the back.

All those who are found to have lacking document(s) must be denied access to the City. For those who during checkpoints have been found to have violated a provision of the previous orders, the PNP are asked to issue a Temporary Operators Permit (TOP) and confiscate the license of the violator.

SECTION 5. DONATIONS - Any person or establishment that will deliver donations within Lapu-Lapu City shall first secure an approval from the city government before entering the city. The LGU shall issue a CERTIFICATE OF TRAVEL to every donor, which shall serve as an authority for the donor to enter the city.

- (a) Donations intended for the Local Government or any of its offices shall be immediately brought to Lapu-Lapu City Hall.

(b) For donations for private individuals or organizations, the donor shall only deliver the donations at the designated area near the first or second bridge and the donee shall pick them up at the said area. The donee shall first secure an approval from the Lapu-Lapu City Government and submit the list of intended beneficiaries and their residences.

(c) The donor is prohibited from conducting barangay-to-barangay or house-to-house deliveries unless there is an approval from the LGU.

SECTION 6. REGULATED SCHEDULE TO PURCHASE FOOD AND ESSENTIAL ITEMS – Effective 20 April 2020, a resident will be allowed to purchase food and essential items in accordance with the following scheme based on the last digit of his/her quarantine pass:

SUNDAY AM: 12:00 am ~ 11:59 AM (Groceries and supermarkets only; Markets will be closed for disinfection)

ODD Numbers: 1, 3, 5, 7, 9

SUNDAY PM: 12:00 nn ~ 11:59 pm (Groceries and supermarkets only; Markets will be closed for disinfection)

EVEN Numbers: 0, 2, 4, 6, 8

- (a) A resident shall be allowed to board the free public transport only if the last digit of his quarantine pass is allowed for that day and upon presentation of a valid ID;
- (b) Markets, grocery stores, and supermarkets and any establishment selling food and other essential items shall first check the control number of the quarantine pass and a valid ID before allowing any resident to enter its premises.
- (c) In the event that a resident with a private vehicle whose plate's last digit is an odd number while the last digit of his quarantine pass is an even number or vice versa, the resident shall be allowed to purchase groceries and foods on the day that his vehicle is allowed to travel. However, the resident must present his vehicle's OR/CR to the market or grocery store to be allowed entry thereat.

- (e) All public and private markets in Lapu-Lapu are closed every Sunday. On this day, vendors shall conduct thorough disinfection of their stalls.
- (f) Every Sunday, market vendors are directed to participate in the Market-on-Wheels activity while their stalls are closed. This is to ensure that residents still have access to food and essential items. Guidelines for the Market-on-Wheels activity shall be issued by the Office of the Market Administrator.

SECTION 7. COOKED FOOD DELIVERIES - Caterers or business establishment selling or supplying cooked meals shall only be allowed to distribute or sell within Lapu-Lapu City. Food deliveries by the caterers for clients outside Lapu-Lapu City shall be strictly prohibited.

SECTION 8. TRAVEL TO OLANGO ISLAND - Travel to Olango Island shall be temporarily prohibited during the enhanced community quarantine. Deliveries to and from Olango shall be up to the Angasil or Hilton wharf only.

SECTION 9. EFFECTIVITY. - This Order shall take effect at 12:01 AM of April 20, 2020 and until the enhanced community quarantine is lifted or withdrawn.
